

THE CORPORATION OF THE VILLAGE OF OIL SPRINGS

By-law No. 711 of 2016

A By-Law of the Corporation of The Village of Oil Springs to amend by-law No. 288 of 1999, for the imposition and collection of fees and charges for certain fire department services

WHEREAS the Council of the Corporation of the Village of Oil Springs may pass a by-law to impose fees or charges for the use, consumption or purchase of a service provided by the municipality;

AND WHEREAS the Council of the Corporation of the Village of Oil Springs deems it expedient to pass such a by-law;

NOW THEREFORE the Council of The Corporation of the Village of Oil Springs enacts as follows:

1. That Schedule 'A' of By-law No. 396 of 2005 be rescinded and replaced by the attached Schedule 'A';
2. That the Mayor and Clerk are authorized to sign the said by-law;
3. This by-law shall come into full force and effect upon the third reading.

Read a first, second and third time and finally passed this 5th day of April, 2016.
